## **Health Declaration Form (Individual)**

### **A. Points to Note**

- ◆ All participants entering the venue are required to submit health declaration form on each competition or event day.
- ◆ All participants are required to wear their own masks and will be subject to temperature check before admission to the competition or event venue.
- ◆ Any person with fever, respiratory symptoms or sudden loss of taste or smell, etc., must not enter the competition or event venue.
- ◆ Information provided will be used for the purpose of preventing the occurrence or spread of infectious disease or contamination, all health declaration forms will be destroyed within 3 months after the competition or event.

### **C. Declaration**

I declare that:

- (1) I do not have any symptoms of COVID-19 (e.g. fever, respiratory symptoms or sudden loss of taste or smell, etc.).
- (2) I am not undergoing mandatory quarantine (including StayHomeSafe Scheme or home isolation) today, i.e. the day of competition or event.
- (3) I belong to the following category (Please ✓ as appropriate):
  - A primary or secondary school student who has fulfilled the latest requirements of “Prevention of Coronavirus Disease 2019 (COVID-19) Health Protection Measures for Schools” issued by the EDB, received two doses of COVID-19 vaccines for more than 14 days\* (for calculation of number of vaccine dosage, please refer to aforesaid “Health Protection Measures for Schools”), and complied with the requirements of Vaccine Pass for entry into non-school premises.  
*\* Starting from 1 October 2022, the arrangements will be stepped up to the completion of three doses of vaccine, excluding those students aged 5 to 11 who are required to receive only two doses of BioNTech vaccines, and students with prior COVID-19 infection who are not required to take the third dose of vaccine. Regarding those students who are still within the time interval waiting to receive the third dose, they should observe the CHP’s recommendation to take the third dose within one week after they are eligible to do so.*
  - An official or other participant who has complied with the Vaccine Pass requirements of the premises (e.g. school, LCSD venue).
  - An official or other participant who holds a “COVID-19 Medical Exemption Certificate” and a negative COVID-19 test result proof conducted within 7 days (calculated from the date of testing). The specimen is collected by combined nasal and throat swabs, but not by self-testing kits.
- (4) I have done the COVID-19 rapid antigen test (RAT) today, i.e. the day of competition or event, and the result of my RAT today was negative.
- (5) If applicable: I am not suspended from face to face / school classes today in light of the epidemic as required by the government.

All information in this form is correct to the best of my knowledge. I understand that making a false statement may jeopardize the health and safety of others who attend the Competition or Event. I will comply with the safety requirements put in place for the Competition or Event that may subject to change at HKSSF’s discretion.

I understand that HKSSF will not have or accept any liability, obligation and responsibility for any loss or damage arising from or associated with violation of precautionary measures and special arrangements set forth by HKSSF in the Competition or Event.
